- (b) if so, the details of such health cards issued to the citizens during the last year, including the States where this scheme has been implemented;
- (c) whether it is a fact that this scheme has not been implemented in some parts of the country;
  - (d) if so, the details thereof; and
- (e) the action taken by Government to implement this scheme in all parts of the country?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI KODIKUNNIL SURESH): (a) and (b) Yes, Sir. Under the Rashtriya Swasthya Bima Yojana (RSBY), smart cards containing biometric details of the beneficiary families are issued to the beneficiaries to get the cashless health insurance cover upto Rs. 30,000/-. As on 28.02.2013, more than 3.41 crore smart cards have been issued in 28 States/Union Territories, namely, Andhra Pradesh, Assam, Arunachal Pradesh, Bihar, Chhattisgarh, Delhi, Gujarat, Haryana, Himachal Pradesh, Jammu and Kashmir, Jharkhand, Karnataka, Kerala, Maharashtra, Manipur, Madhya Pradesh, Meghalaya, Mizoram, Nagaland, Odisha, Punjab, Rajasthan, Tripura, Uttar Pradesh, Uttarakhand, West Bengal, Puducherry and Chandigarh Administration.

(c) to (e) Apart from the 28 States/UTs mentioned above, Tamil Nadu and Goa had participated in the scheme earlier but now have launched their own health insurance schemes. The Rashtriya Swasthya Bima Yojana (RSBY) is not being implemented in the Union Territories of Andaman and Nicobar Islands, Daman & Diu, Dadra and Nagar Haveli and Lakshadweep. Central Government Officers are consistently pursuing with these remaining States/UTs and due to these efforts, Sikkim has initiated the process for implementation of the scheme. However, ultimately it is the decision of the concerned State/UT to implement a scheme sponsored by the Central Government.
