Promotion of games through Ministry

 $2631.\ SHRI\ BASAWARAJ\ PATIL$: Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state:

(a) the games of India which Government is promoting through Ministry;

- (b) the support given by Government to promote these games; and
- (c) the games which were accepted by the Olympic authorities of India?

THE MINISTER OF STATE OF THE MINISTRY OF YOUTH AFFAIRS AND SPORTS (SHRI JITENDRA SINGH): (a) and (b) Primary responsibility for promotion of sports and games is that of the respective National Sports Federations (NSFs). The Ministry of Youth Affairs and Sports and the Sports Authority of India (SAI) supplement the efforts of the NSFs under their various schemes such as Scheme of Assistance to NSFs, Scheme of Talent Search and Training, Scheme of National Sports Development Fund, Scheme of Special Awards to Medal Winners in International Sports Events and their Coaches, Scheme of Pension to Meritorious Sports persons, Schemes of National Sports Awards *viz.* Rajiv Gandhi Khel Ratna, Arjuna Awards, Dronacharya Awards, Dhyan Chand Awards, Maulana Abul Kalam Azad Trophy, Rashtriya Khel Protsahan Puruskar, National Sports Talent Contest (NSTC) Scheme, Army Boys Sports Company (ABSC) Scheme, SAI Training Centres (STC) Scheme, Special Area Games (SAG) Scheme and Centres of Excellence (COE) Scheme.

The Ministry has given recognition to the NSFs of 53 sports disciplines. The list of such Federations is given in the Statement (*See* below). Under the Scheme of Assistance to NSFs, assistance is provided for conduct of National Championships and international tournaments in India, participation of sportspersons in international sports events abroad, organizing coaching camps, engagement of coaches, procurements of sports equipment etc.

(c) Indian Olympic Association (IOA), the apex body for Olympic Sports in India, normally recognises and accepts the games which are played in Olympic Games. As far as recognition by the Ministry of Youth Affairs & Sports is concerned, of the 28 sports disciplines to be played at Rio Olympics, 2016, 22 sports disciplines *viz.*, Aquatics, Athletics, Badminton, Basket Ball, Boxing, Caneoing/Kayaking, Cycling, Equestrian, Fencing, Football, Golf, Handball, Judo, Rowing, Sailing, Shooting, Table Tennis, Taekwondo, Tennis, Volley ball, Weightlifting, and Wrestling have been recognised by the Ministry.

Suspension of IOC

2632. SHRI N.K. SINGH: Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state:

- (a) whether the Indian Olympic Association continues to remain suspended;
- (b) if so, the details thereof;
- (c) whether Indian athletes can compete in Olympic events at the international level under the National Flag;
 - (d) if so, the details thereof; and
 - (e) if not, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF YOUTH AFFAIRS AND SPORTS (SHRI JITENDRA SINGH): (a) Yes, Sir.

(b) The International Olympic Committee (IOC) at its Executive Board meeting held on 4th December 2012 took a decision to suspend the Indian Olympic Association (IOA). Reasons cited by IOC for suspension of IOA are IOA's failure to comply with the Olympic Charter and its statutes, failure to inform the IOC in a timely manner, and as a protective measure against Government interference in the IOA's election process. The Executive Board of IOC has also confirmed that the IOA
