Funds for craftsmen training scheme

739. SHRI Y.S. CHOWDARY: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) the details of funds earmarked for craftsmen training scheme during the last three years;
- (b) the State-wise details of funds allocated during the last three years;
- (c) the details of results achieved during the last three years; and
- (d) whether Government is satisfied with the results achieved so far?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI KODIKUNNIL SURESH): (a) and (b) The Craftsmen Training Scheme (CTS) is implemented by respective State Governments and Union Territory Administrations. The role of Central Government is in formulation of policy, setting norms and standards, granting affiliation, conducting All India Trade Tests (AITT) and issue of certificates etc. Directorate General of Employment and Training under Ministry of Labour and Employment is responsible to carryout above activities for which funds under Non-Plan scheme of CTS are provided. The details of funds earmarked for CTS during last three years is:

These funds are not divided or allocated State-wise.

(c) During the end of financial year 2009-10, the total number of Government and Private Industrial Training Institutes (ITIs) across the country was 8039 with seating capacity of 11.16 lakh which has now increased to 10,750 with seating capacity of 15.24 lakh. The details regarding this increase are at Annex.

(d) The significant increase in number of ITIs and seating capacity is a matter of satisfaction. However, quality and relevance of training in ITIs across the country needs further improvement.

In order to improve quality of training, Directorate General of Employment and Training has operationalized following schemes to modernize the training infrastructure and introduce new courses in ITIs throughout the country.

- (i) Upgradation of 100 ITIs into Centres of Excellence through domestic funding
- (ii) Upgradation of 400 ITIs through World Bank assistance
- (iii) Upgradation of 1396 Government ITIs through PPP.
