- (c) the quantum of share of total production of iron ore in the country being exported; and
- (d) the quantum of demand of iron ore by the public and private sector steel plants installed in the country?

THE MINISTER OF STEEL (SHRI BENI PRASAD VERMA): (a) Yes, Sir. The production of iron ore in the country has been above the domestic requirements during the last three years.

- (b) Decision regarding import of Iron ore is taken by the individual steel producers based on their requirements.
- (c) Details on last three years' iron ore production, domestic consumption, import/export, share of export *vis-a-vis* production are given in the table below:—

  - if not, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF TOURISM (DR. K. CHIRANJEEVI): (a) Development and promotion of tourism is primarily the responsibility of the respective State Government/Union Territory (UT) Administration. However, the Ministry of Tourism (MOT) provides Central Financial Assistance (CFA) to various State Governments/Union Territory Administration for various tourism projects prioritized every year in consultation with them subject to availability of funds, interse priority and adherence to the scheme guidelines. The number of tourism projects and amount sanctioned to various State Governments/UT Administrations during the year. 2012-13 and 2013-14 is given in Statement-I and Statement-II (See below).

(b) and (c) The Ministry of Tourism, Government of India had taken a lead in offering Central Financial Assistance of Rs. 100.00 crore to Uttarakhand immediately after the disaster struck there. Subsequently the total amount of Central Financial Assistance for the year was enhanced to Rs. 253.00 crores inter-alia for rebuilding/ building destroyed/damaged Government tourism assets.

The Ministry of Tourism has sanctioned Central Financial Assistance of Rs. 602.00 lakh in the financial year 2007-08 for Development of Eco Huts at Auli, District Chamoli. Uttarakhand and for Development of Corbett National Park as Tourist Circuit of Rs. 461.62 lakh in the financial year 2010-11.
