## Inquiry into rape incidents

2020. SHRI N.K. SINGH: Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether the National Commission for Women (NCW) has sent its team to various States in the country to inquire into the incidents of rape;
- (b) if so, the details thereof, State-wise and the recommendations, if any, made by NCW; and
  - (c) Government's reaction thereto?

THE MINISTER OF STATE OF THE MINISTRY OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI KRISHNA TIRATH): (a) and (b) Yes Sir, National Commission for Women(NCW) has sent its team to Chhattisgarh, Delhi, Maharashtra, Odisha & Rajasthan to inquire into the incidents of rape. The NCW takes up the matter with the concerned authorities including State Governments. NCW also constitutes Inquiry Committees on some specific incidences of grave injustice or deprivation of women's rights including on the reported cases of alleged rape/gang rape. The recommendations of the Inquiry Committees after approval of the Commission are then forwarded to the concerned State Governments to take appropriate action and follow up in the matter.

(c) Recently, the "Criminal Law (Amendment), Act 2013" has been enacted making the punishment more stringent for offences like rape, besides recognizing various other activities like voyeurism, stalking etc. as offences and crime against women.

## Child care centres

2021. DR. JANARDHAN WAGHMARE: Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the number of registered child care centres/institutions in the country, State/UT-wise;
- (b) whether a number of such centres/institutions which have not been registered are operating in the country;

- (c) if so, the details thereof;
- (d) whether instances of child abuse and lack of residential facility in such centres/institutions have come to Government's notice; and
- (e) if so, the details thereof and steps taken by the Government against such centres/institutions?

THE MINISTER OF STATE OF THE MINISTRY OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI KRISHNA TIRATH): (a) The State/UT-wise number of child care institutions registered under the Juvenile Justice (Care and Protection of Children) Act, 2000 in the country and being provided financial assistance under the Integrated Child Protection Scheme (ICPS) is given in the Statement (See below).

- (b) and (c) The data regarding number of unregistered child care institutes is not maintained centrally.
- (d) The child care institutions are required to be compulsorily registered under the Juvenile Justice (Care and Protection of Children) Act, 2000 and are provided financial assistance under the Integrated Child Protection Scheme (ICPS). The responsibility for implementation of the Act and ICPS is that of the State Government/UT administration. However, at national level, the National Commission for Protection of Child Rights (NCPCR) has enquired into some complaints received by the Commission with regard to instances of child abuse and lack of residential care facilities in child care institutions. The State-wise details of such complaints received by NCPCR are being collected and will be laid on the Table of House.
- (e) The Act and Central Model Rules framed thereunder, provide for monitoring, inspection, standards of care and measures that may be taken by the State Government/UT administration to address any reported instance of child abuse or lack of residential care facilities. The Ministry of Women and Child Development has been urging the State Government/UT Administration from time to time to identify and register all child care institutions, so as to ensure that standards of care can be monitored. In response to complaints received at national level, NCPCR makes recommendations to the State Government/UT administration for taking appropriate action.
