(c) whether Government intends to extend the Unani system of medical treatment, if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI SANTOSH CHOWDHARY) : (a) The Government of India has a National Policy on Indian Systems of Medicine and Homoeopathy-2002, under which Unani System of medicine is covered. The basic objectives of this Policy can be seen in Statement (*See* below).

(b) The details of Unani System's Hospitals and Dispensaries are as stated under:

(c) The Unani System of Medicine is extended to the State Governments through Centrally Sponsored Scheme of Hospital and Dispensaries based on availability of state resource pool and liquidation of pending Utilization Certificates by the States. Under this scheme, financial assistance is provided for infrastructure, equipment and medicine etc. to the states. Besides Central Government has already set up National Institute of Unani Medicine Bangalore for education as well as Central Council for Research in Unani Medicine at Delhi for research activities.

**Statement***Objectives of the policy*

The best objectives of the Policy are:

- (a) To promote good health and expand the outreach of healthcare to our people, particularly those not provided health cover, through preventive, promotive, mitigating and curative intervention through ISM & H.
  - (b) To improve the quality of teachers and clinicians by revising curricula to contemporary relevance and researches by creating model institutions and Centres of Excellence and extending assistance for creating infrastructural facilities.
  - (c) To ensure affordable ISM & H services and drugs which are safe and efficacious.
  - (d) To facilitate availability of raw drugs which are authentic and contain essential components as required under pharmacopoeial standards to help improve quality of drugs, for domestic consumption and export.
  - (e) Integrate ISM & H in health care delivery system and National Programmes and ensure optimal use of the vast infrastructure of hospitals, dispensaries and physicians.
  - (f) Re-orient and prioritize research in ISM & H to gradually validate therapy and drugs to address in particular the chronic and new life style related emerging diseases.
  - (g) Create awareness about the strength of these systems in India and abroad and sensitize other stakeholders and providers of health,
  - (h) To provide full opportunity for the growth and development of these systems and utilization of the potentiality, strength and revival of their glory.
