1.	National Aids Control Organisation (NACO)	Utilization Certificates received. Further funds are provided to NGOs after receipt of Audited Utilization Certificates and therefore in a year there cannot be pending Utilization Certificates
2.	NGO Division, Ministry of Health and Family Welfare	No direct grants are released to NGOs. Utilization Certificates are being received in respect of Grants released to Regional Resource Centers (RRCs), who provide capacity building support to Field level NGOs.
3.	Tuberculosis Division (TB)	Utilization Certificates are being received by the Ministry.
4.	AYUSH	Information as per Annexure-I
5.	PNDT	The Functioning of the grantee NGOs was reviewed from time to time on the basis of Progress Reports, Audited Statements of Expenditure, Utilization Certificate and track verification report from concerned District Authorities, before release of the next installment.

Funding of rural health infrastructure

2096. SHRI RAMA CHANDRA KHUNTIA : Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state :

(a) whether engaging Asha workers and 108 ambulance and grant for the development of infrastructure of health in rural areas are part of Central Government's National Rural Health Mission or exclusively State Governments programme; and

(b) what are the programmes implemented as part of NRHM and total money given under different schemes to different States, State-wise and Scheme-wise from 2004 to 2008 and 2008 to 2013?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI GHULAM NABI AZAD) : (a) Public health is a state subject. National Rural Health Mission (NRHM) is a Centrally Sponsored Scheme and under NRHM, financial support is provided to States/UTs to strengthening their health care delivery system including support for engaging ASHAs and patient transport ambulances and development of health infrastructure in rural areas based on the requirements posed by the States/UTs in their Programme Implementation Plans.

(b) The programmes/schemes that have been implemented as part of NRHM include Reproductive and Child Health (RCH) Programme, Integrated Disease Surveillance Programme (IDSP), National Iodine Deficiency Disorders Control Programme (NIDDCP), National Leprosy Eradication Programme (NLEP), National Vector Borne Disease Control Programme (NVBDCP), Revised National TB Control Programme (RNTCP), Routine Immunization (RI), Pulse Polio Immunisation (PPI), Infrastructure Maintenance (IM) and Additionalities under NRHM. Funds given schemewise and statewide are Annexed [See Appendix 230 Annexure No. 17]
