substantial investment and increasing public expenditure on schemes like Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), Swarana Jayanti Shahari Rozgar Yojana (SJSRY); Prime Minister's Employment Generation Programme (PMEGP); Swarnajayanti Gram Swarozgar Yojana (SGSY) now restructured as National Rural Livelihood Mission (NRLM). In addition, Government has decided to enhance sources of funding of skill development programmes. For example, it has been decided to use at least 10% of Special Central Assistance to Tribal Sub-Plan (SCA-TSP), Special Central Assistance to Scheduled Castes Sub-Plan (SCA-SCP), Multi-sectoral Development Programme funds and 5% of Border Area Development Programme funds for skill development.

Pending rape cases

†*315. SHRI NARESH AGRAWAL: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the State-wise details of number of rape cases pending in various courts of the country;
- (b) whether Government has appealed to the courts for disposal of pending rape cases; and
 - (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI R.P.N. SINGH): (a) As per information provided National Crime Records Bureau (NCRB), the data on number of rape cases on trial, pending and cases in which trials were completed is given in Statement (See below).

(b) and (c) Government has written to the Chief Ministers of all States and Chief Justices of all High Courts to set up Fast Track Courts for speedy trial of pending rape cases in District/Subordinate Courts having a high pendency and to monitor the progress of the cases to ensure their timely disposal. The States have been requested to utilize the additional positions of Judges being created in the Subordinate Judiciary in pursuance of the directions of the Supreme Court in Brij Mohan Lal case for this purpose. Government has approved making available to the State Governments 50% of the salary of these additional judges from the funds available under the 13th Finance Commission Award for morning/evening/shift courts up to 31st March, 2015.

Ministry of Home Affairs had issued an advisory on crimes against women in 04.09.2009, wherein the States/UTs were directed to set up Fast Track Courts.

The States have responded by designating special courts from out of the existing courts, for fast tracking such cases.
