- (b) whether it is a fact that all the nine conditions as required under Thirteenth Finance Commission's Recommendations have been fulfilled by Gujarat Government; and
  - (c) if so, by when the Ministry wants to release the performance grants?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRIMATI DEEPA DASMUNSI): (a) to (c) The Thirteenth Finance Commission (FC-XIII) has estimated the Basic and the Performance Grant for Urban Local Bodies (ULBs) in Gujarat to the extent of Rs. 851.13 crore and Rs. 450.67 crore respectively. The Basic Grant is available during the award period, 2010-15. The Basic Grant of Rs. 547.47 crore, due up to the 1st Instalment of 2013-14, has been released to the State of Gujarat for ULBs by the Department of Expenditure, Ministry of Finance.

The Performance Grant, beginning from 2011-12, is available for a period of four years to States that meet certain performance based conditions prescribed by the 13th Finance Commission (FC-XIII). However, where a State is unable to meet these conditions by 31st March of a particular fiscal year, its entitlement to the performance grant is forfeited, total amount of the performance grants so forfeited for the particular year are then redistributed. While 50 percent of the aggregated amount so forfeited is divided amongst all the states (both performing and non-performing) according to shares indicated in FC-XIII report; the remaining 50 percent of the aggregate forfeited performance grant is distributed only amongst the States that have complied with the stipulated conditions in the ratio of their entitlements as specified in FC-XIII report. Gujarat was not eligible for performance grant for 2011-12 and 2012-13 as it did.

## Buses under JNNURM in Andhra Pradesh

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRIMATI DEEPA DASMUNSI): (a) and (b) Ministry of Urban Development has sanctioned Additional Central Assistance (ACA) for procurement of 1037 buses to

Government of Andhra Pradesh for its 11 cities under Jawaharlal Nehru National Urban Renewal Mission (JnNURM) during 2013-14 (as on 30.01.2014). City wise details are given in Statement (See below).

(c) The bus funding scheme under JnNURM extended phase is meant for implementation upto 2014-15.
