THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI UPENDRA KUSHWAHA): (a) to (c) As per the data available in the Programme Management Information System (MIS), the payments amounting to ₹12,673.14 crore were delayed beyond the stipulated period of 15 days under Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) in 2013-14.

Schemes for development of rural areas

Will the Minister of RURAL DEVELOPMENT be pleased to state:

(a) the details of schemes implemented/being implemented by Government for potential development of rural areas in the country;

(b) the details of funds allocated, released and utilized under each of these schemes during the last three years, State-wise and scheme-wise; and

(c) the steps being taken by Government to address the grey areas in the implementation of those schemes?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI UPENDRA KUSHWAHA): (a) The Ministry of Rural Development is implementing, through State Governments, different rural development programmes, namely, Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) for wage employment, Swarnjayanti Gram Swarozgar Yojana (SGSY)/National Rural Livelihoods Mission (NRLM) for self-employment, Indira Awaas Yojana (IAY) for rural housing, Pradhan Mantri Gram Sadak Yojana (PMGSY) for rural connectivity and National Social Assistance Programme (NSAP) for social assistance to rural poor. These programmes are aimed at betterment of rural livelihoods and overall development of rural areas through creation of employment opportunities, infrastructures and providing social assistance to the rural poor.

(b) State-wise funds allocated, released and utilized under various rural development programmes during the last three years are given in the Statement-I to IV (*See below*).

(c) The Ministry of Rural Development has developed a comprehensive system of monitoring the implementation of programmes including utilization of funds through Periodical Progress Reports, Performance Review Committee, Area Officer's Scheme, Vigilance and Monitoring Committee at the State/District Level and National Level Monitors. Besides, the State Governments have been advised to adopt five pronged strategies, which are (i) creation of awareness about the schemes, (ii) transparency, (iii) people's partnership, (iv) accountability, social audit and (v) strict vigilance and monitoring at all levels to improve the implementation of the programmes.
