THE MINISTER OF STATE OF THE MINISTRY OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH) (SHRI SHRIPAD YESSO NAIK): The existing National Institutes under the Ministry and their functions are as under:-

1. National Institute of Ayurveda, Jaipur, Rajasthan

**Functions:** Conducting Under Graduate/Post Graduate Courses in Ayurveda System of Medicine and patient care activities.

2. National Institute of Homoeopathy, Kolkata, West Bengal

Functions: Conducting PG courses in Unani Medicine and patient care activities.

National Institute of Siddha, Chennai, Tamil Nadu 4.

Functions: Conducting Post Graduate courses in Siddha and patient care activities.

National Institute of Naturopathy, Pune, Maharashtra

Functions: To conduct and facilitate research activities in all aspects of human health, to develop Naturopathy as a System of Medicine, to provide facilities for training in Naturopathy and patient care activities.

Rashtriya Ayurveda Vidyapeeth, New Delhi

Functions: Promotion of knowledge of Ayurveda, by conducting Certificate of Rastriya Ayurveda Vidyapeeth (CRAV) and Members of Rastriya Ayurveda Vidyapeeth (MRAV) courses under Guru-Shishya Parampara.

7. Morarji Desai National Institute of Yoga, New Delhi

Functions: To develop, promote and propagate the science and art of Yoga, to provide and promote facilities of training, teaching and research. The Institute is conducting a Under Graduate Course in Yogic Science.

Institute of Post Graduate Teaching and Research in Ayurveda, Jamnagar (It is financially assisted by the Ministry but administratively controlled by Gujarat Ayurveda University)

Functions: To conduct Post Graduate course in Ayurveda and patient care activities. New Institutes under construction:

All India Institute of Ayurveda, Sarita Vihar, New Delhi

Functions: Apex institute of Ayurveda with 200 bedded referral hospital to impart education in the field of Ayurveda at M.D. and Ph. D level.

North-Eastern Institute of Ayurveda and Homoeopathy, Shillong

Functions: A state of the art institute consisting of Ayurveda College and

Homoeopathy College along with attached hospitals of Ayurveda and Homoeopathy of 100 beds and 50 beds respectively.

North-Eastern Institute of Folk Medicine, Pasighat, Arunachal Pradesh

Functions: Centre of Excellence and Apex Research Centre for all aspect of Folk Medicine knowledge with linkage and collaboration with other research institutions.

Setting up of any Institutes during the Tewlfth Plan depends on availability of Budget provision and land.

## Modernization of airports in Telangana and Andhra Pradesh

- 934. SHRI GARIKAPATI MOHAN RAO: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) the status of development, upgradation and modernization plan undertaken for the airports in the country;
- (b) the names of such airports selected in the States of Telangana and Andhra Pradesh; and
- (c) the funds allocated and the time frame fixed for the proposed development of airports in Telangana and Andhra Pradesh?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION (DR. MAHESH SHARMA): (a) Development of airports is a continuous process and is undertaken by Airports Authority of India (AAI) from time to time depending upon commercial viability, traffic potential/demand, technical feasibility, availability of land, etc. Details of major development, upgradation and modernization works for AAI managed airports in the country are given in Statement (See below).

- (b) Airports at Tirupati, Vijayawada and Rajahmundry Airports in Andhra Pradesh are identified by the Airports Authority of India. In Telangana, the airport at Shamshabad was commissioned in 2008 with international standards and world class facilities.
- The project for construction of terminal building at Tirupati Airport has been undertaken by Airports Authority of India (AAI) at a cost of ₹ 174.08 crores by 100% budgetary support from Government of India. Fund outlay is considered on case to case basis depending on socio-economic considerations, finalization of project costs etc.
