(b) Several Insurgent/militant groups are operating in the North East Region including Manipur with cross-border support challenging the sovereignty and integrity of the Nation. Decisions on matters concerning security of the Nation are taken, keeping in view the ground realities.

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI DHARMENDRA PRADHAN): (a) The amount of subsidy on petroleum products namely; Diesel, PDS Kerosene and Subsidized Domestic LPG during last three years is given as under:

- (b) The Government has taken following actions to reduce subsidy/under recovery on the petroleum products:
  - (i) Diesel: In order to reduce under-recovery on sale of Diesel, the Government on 17.01.2013 authorized the OMCs to (a) increase the retail selling price of Diesel in the range of 40 paisa to 50 paisa per litre per month (excluding VAT); and (b) sell Diesel to all consumers taking bulk supplies directly from the installations of the OMCs at the non-subsidized market determined price. Effective 19th October 2014, the price of Diesel has been made market determined for all consumers.
  - (ii) **PDS Kerosene:** The quota of PDS Kerosene has been rationalized over the years resulting in reduction in subsidy.

- (iii) Domestic LPG: Effective 14.9.2012, the Government decided to cap the supply of Subsidized Domestic LPG cylinders for each domestic LPG consumer to 6 cylinders (of 14.2 Kg) per annum, which was subsequently increased to 12 cylinders since 30.1.2014. The Government has also launched Modified Direct Benefit Transfer on LPG (DBTL) scheme w.e.f. 15.11.2014 in 54 districts for direct transfer of subsidy. The scheme is due to be launched in rest of the country w.e.f. 01.01.2015. This will reduce diversion of domestic LPG.
- (c) and (d) As regards the impact of reduction in subsidy on inflation, Petrol being largely an item of final consumption, has a limited impact on inflation while the impact of price hike in diesel on inflation, is higher. The estimated product wise impact of increase in prices over the WPI index is given below:
