Delay in compensation to families of victims of Maoist/Naxal attack

†1159. SHRI NARESH AGRAWAL: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether Government receives complaints regarding non-receipt or extraordinary delay in getting the amount of compensation declared for the family members of martyrs of Maoist/Naxal attack;

- (b) if so, the strategy of Government for its solution; and
- (c) if not, the number of days Government takes to provide the amount of compensation to the family members of the martyrs?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI HARIBHAI PARTHIBHAI CHAUDHARY): (a) to (c) The State Governments have their own compensation policy for the families of civilians and the State Police personnel killed in Left Wing Extremism (LWE) violence. However, under the Security Related Expenditure (SRE) Scheme, the Central Government reimburses to the State Governments the *ex-gratia* payment of upto ₹1 lakh to the family of civilian killed and ₹3 lakh to the family of security personnel killed in LWE violence. Besides, the Government of India is administering a Scheme titled "Central Scheme for Assistance to Civilian Victims of Terrorist/ Communal/ Naxal Violence" under which the payment of assistance to the victims/ next of kin of victims are paid by the District Magistrate/ Deputy Commissioner concerned and thereafter the State Government submits the proposal to the Ministry of Home Affairs for reimbursement.

In the cases of death of the Central Armed Police Forces (CAPFs) personnel, papers for *ex-gratia* compensation are submitted to the Ministry of Home Affairs within a period of 5 months from the date of date of the CAPF personnel and there is an internal time schedule for processing cases at each level in the organization.
