Upgrading of CGHS communication technology network

2612. DR. T. N. SEEMA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government has taken note of inconvenience caused to the beneficiaries due to frequent break down/deficient internet services and obsolete server/computers in Government hospitals/CGHS dispensaries;
 - (b) if so, the details thereof and the reasons therefor;
- (c) the details of the complaints received in this regard, State-wise, during each of the last three years and the current year; and
- (d) the time by which the compliant heavy duty servers and computers with updated technology are likely to be provided at Government hospitals/CGHS dispensaries and the corrective action taken by Government in this regard?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI JAGAT PRAKASH NADDA): (a) to (d) Since Health is a State subject, no such information is maintained centrally. As far as CGHS is concerned, inconvenience caused to beneficiaries due to frequent break down/deficient internet services and obsolete server/computers have been noted. The reasons includes slow server, out of order computers, break down of lease line, local internet, non-availability of some of the software, etc.

The details of such complaints received in CGHS are given in the Statement (See below). Old servers have been replaced with 5 Virtual Machine at National Data Centre, Shastri Park, Delhi for CGHS resulting in improvement of CGHS web application accessibility.

As far as three Central Government Hospitals viz., Safdarjung Hospital, Dr. Ram Manohar Lohia Hospital and Lady Hardinge Medical Collage and Associate Hospitals are concerned, no inconvenience is caused to the patients as there are no cases of frequent break down/deficient internet break down/deficit internet services and obsolete server/computers in these hospitals.

Rumours on Ebola disease in India

2613. SHRI K. RAHMAN KHAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the precautionary steps taken by Government to prevent the spread of Ebola in the country;
- (b) whether Government is aware that in the social media certain persons are scaring the citizens that the dreaded disease has entered India; and
 - (c) if so, whether Government will dispel such rumours?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI JAGAT PRAKASH NADDA): (a) Government has taken a series of measures to prevent entry of Ebola Virus Disease into the country and to contain it rapidly, if a case is reported in India. There is screening of passengers coming from affected countries at 18 International airports and 9 major ports. Government has decided to reroute passengers from affected countries to seven International Airports at Delhi, Kolkata, Mumbai, Chennai, Bangalore, Hyderabad and Kochi. The Integrated Disease Surveillance Programme is tracking such passengers arriving from affected countries having history of contact with a suspect or confirmed Ebola Case. Two laboratories namely National Institute of Virology, Pune and National Centre for Disease Control, Delhi are testing clinical samples of high risk passengers. State Governments have identified isolation facilities. Training for Master Trainers and Rapid Response teams of the States/Union Territories have been accomplished. Personal Protective Equipments have been provided to the States/Union Territories.
