Change in the name of Hyderabad International Airport

- (a) whether Government changed the name of Hyderabad International Airport from Rajiv Gandhi Airport to N.T. Rama Rao Airport without consulting the State Government;
- (b) if so, whether any representations or protests have been received from MPs and public representatives; and
- (c) if so, the reaction of Government in restoring the name of Rajiv Gandhi Airport at Hyderabad?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION (DR. MAHESH SHARMA): (a) to (c) No, Sir. The name of the Domestic side of the Terminal at Hyderabad International Airport, has only been restored as N.T. Rama Rao Domestic Terminal as it was earlier known at Begumpet Airport, Hyderabad. The Hyderabad International Airport will continue in the names of both Late Shri Rajiv Gandhi and Late Shri N.T. Rama Rao.

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION (DR. MAHESH SHARMA): (a) Operation of any airline is a commercial decision of that airline and the Government does not interfere in the commercial judgement of the airlines for operations on any route. As per information provided by Air India, the international traffic potential between Bhopal and Indore to any international destination is not large enough to justify commencement of International flights from Bhopal and Indore. Indore Airport is already having functional international cargo facility under the outsourced model.
