

exclusively of women through trade related training, information and counseling extension activities related to trades, products, services etc. Under the Scheme financial loans are provided by Nationalized Banks and grants by Government of India at the rate of 30% of the loan subject to maximum limit of ₹ 30.00 lakh through NGOs for capacity building and for undertaking self-employment ventures by women in non-farm activities. Under Mahila Coir Yojana, financial assistance is provided for motorized ratts for spinning coir yarn to women artisans after giving training. Government provides motorized ratts/ motorized traditional ratts at 75% cost subsidy subject to a maximum ceiling of ₹ 7500/- for motorized ratts and ₹ 3200/- for motorized traditional ratts. The remaining 25% is raised by the beneficiaries.

Fund allocated for these Schemes during the current year (2015-16) is ₹ 6.70 crore. Since these are Central Sector Schemes, funds are not allocated State/ UT-wise.

(d) The Governments of Chhattisgarh and Uttar Pradesh are implementing Women Entrepreneurship Award Scheme and Mahila Udyami Protasahan Yojana, respectively for development of women entrepreneurship.

- (a) the number of Micro, Small and Medium Enterprises in the country for last two years as on 31st March, 2015;
- (b) State-wise number of each category of these enterprises;
- (c) the total employment generated by these enterprises, State-wise; and
- (d) the total credit made available by the Central and State Governments to these enterprises?

THE MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI KALRAJ MISHRA): (a) to (c) As per the latest Census (Fourth Census) as well as data extracted from Economic Census 2005 conducted by Central Statistics Office, Ministry of Statistics and Programme Implementation, for activities excluded, namely wholesale/retail trade, legal, educational and social services, hotel and restaurants, transports and storage and warehousing (except cold storage), the total number and employment of Micro, Small and Medium Enterprises are 361.76 lakh and 805.24 lakh, respectively. The employment generated by the MSME filing Entrepreneurs Memorandum Part-II (EM-II) under Micro, Small and Medium Enterprises Development Act 2006 is not centrally maintained. The number of MSMEs which had filed EM-II are 7.88 lakhs for the last two years. State-wise details are given in the Statement (*See below*).

(d) As per the information made available by Reserve Bank India 'Outstanding credit to MSMEs by Scheduled Commercial Banks (SCBs) as at the end of March, 2015 was ₹ 11,94,173 crore'.

### Registration of recruitment agents

SHRI AMBETH RAJAN:

Will the Minister of OVERSEAS INDIAN AFFAIRS be pleased to state:

(a) whether Government has received proposals/applications during the current year from various States for issue of recruiting agent certificate for overseas manpower supply, and if so, the details thereof, State-wise;

(b) whether any amendments have been made to the guidelines for registration of recruiting agents and if so, the details thereof;

(c) whether any mechanism has been put in place to regulate and monitor recruitment agencies/agents and if so, the details thereof; and

(d) the number of agencies/agents against whom action was initiated during the last one year for fraudulent activities, State-wise, including Himachal Pradesh?

THE MINISTER OF STATE IN THE MINISTRY OF OVERSEAS INDIAN AFFAIRS [GENERAL (RETD.) V.K. SINGH]: (a) The Government has received 63 applications/proposals for issue of Recruiting Agent Certificate for overseas manpower supply and the details are given in Statement-I (*See below*).
