(b) to (f) The issue was discussed in an Inter Ministerial meeting on 17.8.2004, with the representatives of the Ministry of Home Affairs, Department of Legal Affairs, Department of Expenditure and the Planning Commission. Subsequently, a note was submitted to the Prime Minister for consideration and the directions received in this regard are being processed.

Assistance to voluntary organisations/agencies

- (d) the details of the agencies which are monitoring and auditing such organisations?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI KANTI SINGH): (a) The basic criteria used for selection of NGOs and other agencies for operating the programmes of Department of Women and Child Development include the following:

- (i) Registered under one of the relevant statutory acts;
- (ii) In existence for a period of at least three years after registration;

- (iii) Have audited statements of Accounts for last three years;
 - (iv) Financial sound;
 - (v) Recommendation of State Governments/State Level Empowered Committees constituted for the purpose;
 - (vi) Experience in relevant field.
- (b) No, Sir.
- (c) Details of the agencies to whom funds were released State-wise and scheme-wise for the last three years are available in the respective Annual Reports of the Department. Information on release of grants State-wise for the current year (till date) is in the Statement (See below).
- (d) A system exists to review the performance of various organisations through periodical reports, review meetings and field visits by the concerned Programme Officers.
