concerted efforts for accelerating socio-economic development of Scheduled Tribes maintaining their distinct culture, envisages socio-economic empowerment and documentation of rich traditional practices and wisdom enshrined in the tribal culture. It also addresses the problems of poverty, health and nutrition, sanitation and environmental hygiene in tribal communities by appropriate measures and provides a strong and effective relief and rehabilitation system to ameliorate the miseries of tribals due to displacements. Aslo the two draft policy considers formal education as the key to all-round human development. It attempts to address the problem of education among the ST populations and suggests a number of remedial measures to ensure better education among the tribals.

Rehabilitation of landless tribals of Vishakhapatnam

- 1120. SHRIMATI N. P. DURGA: Will the Minister of TRIBALAFFAIRS be pleased to state:
- (a) whether adequate measures have been taken to help landless poor tribals displaced be bauxite mining of areas of Vishakhapatnam;
 - (b) if so, the details thereof; and
- (c) the action taken to ensure that adivasis are not deprived of their rights in their domain?

THE MINISTER OF TRIBAL AFFAIRS (SHRI P. R. KYNDIAH): (a) to (c) As per the information received from the State Government of Andhra Pradesh there are no leases for bauxite in Vishakhapatnam and consequently there is no displacement of tribals. Besides, a National Policy on Resettlement and Rehabilitation for Project Affected Families has been circulated by the Ministry of Rural Development which ensures the minimum benefits to the displaced persons including the tribals.

Financial assistance to students

- 1121. SHRI JANARDHANA POOJARY: Will the Minister of TRIBAL AFFAIRS be pleased to state:
- (a) whether Government release financial assistance to the State Governments under the Centrally sponsored schemes for construction of

hostels, ashrams, grant of scholarships, creation of book banks, etc., for pre and post-metric and university students belonging to STs and for training such students for their Board and other competitive examinations;

- (b) if so, the details of the Central assistance released for various activities during the last five years, State-wise, year-wise and activity-wise;
- (c) whether any requests from the Government of Karnataka for assistance to implement various such projects are pending consideration of the Central Government; and
 - (d) if so, the present status of each proposal?

THE MINISTER OF TRIBALAFFAIRS (SHR P. R. KYNDtAH): (a) and (b) Yes, Sir. The grant-in-aid released during the last five years for ST students under the schemes of construction of Girls/Boys Hostels, Ashram Schools, Post Martic Scholarship, Books, Upgradation of Merit and Coaching and Allied to various State Governments/UT Administrations, year-wise and scheme-wise is at Statement (See below).

- (c) and (d) The State Government of Karnataka has submitted a few proposals to Ministry of Tribal Affairs as per details given below alongwith their status:—
- (i) Girls/Boys Hostels:—The proposal was incomplete because it did not include the Utilization Certificate of the previous grant, cost of estimates as per the prevailing rates of CPWD/PWD and Physical Progress Report of the hostels sanctioned in previous years. State Government has been requested for clarification/information.
- (ii) Ashram Schools:—The proposal was incomplete because it did not include the Utilization Certificate of the previous grant and Physical Progress Report of Ashram Schools sanctioned in previous years. State Government has been requested for clarification/information.
- (iii) Post Matric Scholarship (PMS): The proposal has been processed.
- (iv) Coaching and Allied: —The Proposal has been processed.
