- (b) if so, the outcome thereof;
- (c) whether it is a fact that most of the schools in NCT of Delhi do not provide fee-waivers to the disabled and these schools do not have pro-poor admission policy; and
  - (d) if so, what steps Government propose to take in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI M.A.A. FATMI): (a) and (b) No, Sir. However, Media Management Group for Literacy and Development, New Delhi, an NGO, has conducted a study on "Public Utility of Private School" on the recommendation of this Ministry. The broad outcomes of the study are:

- Private schools are not contributing enough to the society.
- Out of every Rs. 100 spent by the Government towards the subsidy to the private schools, only Rs. 27 are spent towards the socially useful activities.
- 80% of the sample private schools made profit out of such subsidies.
- \* 20% of the sample schools spent much more than the subsidies received by them from the Government on welfare actitivies.
- (c) and (d) Schools run by Government of NCT of Delhi and those being provided Grant-in-aid, do not charge any tuition fee from any student. All Unaided recognized schools of Delhi have been instructed *vide* NCT of Delhi's Order dated 27th April, 2004 for providing free education to 20% children belonging to weaker sections of the society.

## Appointments of teachers in KVS

- **₹052.** SHRI LALIT SURI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) whether final result for recruitment of Trained Graduate Teachers by the Kendriya Vidyalaya Sangathan was declared on the 8th May, 2004 but no appointments have so far been made;

- (b) if so, the reasons for delay in making appointments, the number of persons who were empanelled on the basis of the test, the number of vacancies likely to be filled up during 2004-05 and 2005-06, separately; and
- (c) by when the selected candidates are expected to receive appointment letters?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI M.A.A. FATMI): (a) to (c) The results for recruitment of Trained Graduate Teachers were declared on 12th May 2004. 403 candidates have been recommended for appointment as Trained Graduate Teachers for the year 2004-05. 1025 vacanices of Trained Graduate Teachers exist as on 31st Oct. 2004 and about 200 vacancies of TGTs are likely to occur in the remaining period of 2004-05 on account of retirement and promotion etc. About 500 vacancies of TGTs are going to fall vacant during 2005-2006. As such about 1700 vacancies of TGTs will be vacant during 2004-05 and 2005-06. About 400 vacancies of TGTs would be filled up by promotion from PRTs during 2004-05 and the remaining vacancies are likely to be filled up during 2005-06 by promotion as well as by direct recruitment.

The matter of appointment of Trained Graduate Teachers is under review and a decision would be taken as soon as the review is completed.
