US refusal for Indian AIDS Drugs

129. SHRI RAMAMUNI REDDY SIRIGIREDDY: SHRI K. RAMA MOHANA RAO:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact the US Food and Drug Administration refused to give its approval for use of WHO-approved AIDS drug combinations manufactured by Indian drug manufacturers in US-funded programmes; and

(b) if so, the steps Government have taken through diplomatic and political channels, to convince USA to use these drugs in US sponsored or funded programmes?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI PANABAKALAKSHMI): (a) and (b) There is no information available with the Government that AIDS drug combinations of Indian manufacturers, approved by WHO, under its prequalification scheme, are being refused by US, FDA for their acceptance under US funded Programmes for supply for AIDS drugs. It is, however, understood that for supply of AIDS drugs to developing countries, against the funds provided under US President's Emergency Plan for AIDS Relief (PEPFAR) tentative approval of US, FDA about safety and efficacy standards of these drugs would be required.

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI PANABAKA LAKSHMI): (a) and (b) Government is in the process of introducing a comprehensive Bill to regulate certain para-medical professions including physiotherapy. A Council for physiotherapists will be constitute once the relevant legislation comes into force.

Typhoid kit

131. SHRI RAMAMUNI REDDY SIRIGIREDDY: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact that DRDO has developed a kit for Typhoid;

(b) if so, the details thereof;

(c) whether mass production of this kit has been started; and

(d) if so, by when the kit is going to be distributed to various hospitals in the country?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI PANABAKA LAKSHMI): (a) to (d) DRDO has reported that the Organisation has developed a kit for Typhoid. This kit is based on antigen detection and diagnosis is achieved within 1 -3 minutes. The kit is suitable for use in field. Each kit carries regents to perform 30 tests. No special training is required to use the kit. The regent is highly sensitive, specific and is stable at 4°C for more than 9 months. DRDO has transferred the technology to M/s Xcyton Diagnostics Limited, Bangalore and the kit is proposed to be launched by mid August, 2004.
