Measures to tackle noise poliution offenders in Delhi

336. SHRIMATI PREMA CARIAPPA: SHRI MOTILAL VORA:

Will the Minister of HOME AFFAIRS be pleased to state.

- (a) whether it is a fact that Government have purchased equipment to measure noise pollution levels in the NCT of Delhi;
- (b) whether it is also a fact that hi-tech cops have been trained to crack down on noise pollution offenders who violate the prescribed limits or play music too loudly after fixed timings; and
- (c) if so, the details thereof, and how many offenders have been challened during the last three months?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI S. REGHUPATHY): (a) Yes, Sir. Delhi Police have purchased 38 noise-level meters.

(b) and (c) Yes, Sir. Delhi Police have imparted training to their 96 officers of the rank of Assistant Commissioners of Police and Inspectors of Police in operation of the noise level meters. During the last three months from 1st April, 2004 to 30th June, 2004, Delhi Police prosecuted 78 persons under sections 28 and 112 of the Delhi Police Act, 1978 and section 133 of "the Code of Criminal Procedure, 1973" for causing noise pollution and imposed in all a fine of Rs. 37,93,500/- under the Motor Vehicles Act, 1988 for using pressure horns, etc.

Fencing at Indo-Bangladesh border

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether barbed wire fence along the Indo-Bangladesh border has been completed;
