Safety Norms for Sports Utility Vehicles

- 472. SHRI K. RAMA MOHANA RAO: Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:
- (a) whether it is a fact that Government are seriously thinking of adopting strict safety norms for Sports Utility Vehicles (SUVs);
- (b) whether Government propose to ban third row of seats which is a problem area;
- (c) whether any meeting with the vehicle manufacturers has been convened in this connection;

- (d) if so, what are the suggestions made by the vehicle manufacturers; and
 - (e) what action Government have taken on those suggestions?

THE MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS (SHRI K.H. MUNIYAPPA): (a) Sports Utility Vehicles (SUVs) as a separate category are not recognised by the Government. All safety norms as are applicable to the cars having seating capacity upto 8 passengers, also apply to such vehicles.

- (b) There is no legal bar for a third row of seats and as of now there is no move to ban third row of seats in such vehicles.
- (c) The Ministry has not held any meeting with the vehicle manufacturers.
 - (d) and (e) Do not arise.

Highways In Bihar

- †473. SHRIMATI KUM KUM RAI: Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:
- (a) the length of highways, in kms., to be constructed in Bihar during this financial year;
 - (b) the number of four-lane highways out of these; and
- (c) the amenities to be provided on the highways under construction?

THE MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS (SHRI K.H. MUNIYAPPA): (a) Construction of new roads as National Highways is not envisaged at present. Only existing National Highways are being improved in a phased manner depending upon *inter* se priority and availability of funds. Improvement of about 490 kms. is targeted to be completed in the current Financial Year.

(b) Four-laning is targeted to be substantially completed this year in 206 kms. on NH- 2 and 10 kms. on NH-31, aggregating to the length of 216 kms. out of 490 kms.
