- (a) whether it is a fact that establishment of industrial capacity of oilseeds crushing has increased during the last few years in the country;
- (b) if so, the oilseeds crushing capacity established till the end of March, 2004;
- (c) whether oilseeds are available for maximum utilization of the crushing capacity; and
- (d) if not, the average percentage of production capacity of oilseeds crushing industry being used?
