Agriculture being a State subject, State level SFACs are to be set up by the State Governments. However, national level SFAC facilities establishment of State level SFACs and makes contribution in their corpus fund. National SFAC, so far, has contributed corpus fund for creation of 17 States level SFACs as independent entities.

(c) and (d) No, Sir. The establishment of State level SFAC in Maharashtra is under active consideration of the State Government. National SFAC has already pledged support by way of contribution towards corpus fund.

- i) Development of Commercial Horticulture through Production and Post Harvest Management;
- ii) Capital Investment Subsidy Scheme for Construction/ Expansion/Modernisation of Cold Storages and Storages for Horticulture Produce; and
- iii) Technology Development and Transfer for Production of Horticulture.

The details of the projects sanctioned and financial assistance provided under the above schemes during the years 2000-01 to March, 2004, State-wise, are given in Statement-I, II and III respectively.
