offer themselves for fresh assessment after obtaining Ph.D and/or fulfilling other requirements for promotion as Reader and, if found suitable, could be given the designation of Reader.

A lecturer in the Senior Scale will be eligible for promotion to the post of Reader if she/hcj has:

- i) Completed 5 years of service in senior scale.
- ii) Obtained a Ph.D degree or has equivalent published work.
- iii) Made some mark in the areas of scholarship and research as evidenced e.g. by self assessment, reports of referees, quality of publications, contribution to educational innovation, design of new courses and curricula and extension activities.
- iv) After placement in the Senior scale participated in two refresher courses/summer institutes of approved duration, or engaged in other appropriate continuing education programmes of comparable quality as may be specified or approved by the University Grants Commission, and
- v) Possesses consistently good performance appraisal reports.
- (c) and (d) In terms of the provisions of the Government of India Notification No.F.1-22/97-U.I. dated 27.7.1998, UGC has since issued a Notification No.F.3-1/94(PS) dated 24.12.1998. This Notification *vide* its clauses No. 7.2.0(ii) and 7.4.1(v) contain such provision. UGC has not prepared any list of programmes of comparable quality.
  - (e) and (f) The question does not arise.
