some items, the gap between income and expenditure in the foreign trade is continuously growing;

- (b) if so, names of those five items of the country import of which have risen during the last five years; and
- (c) the average annual increase in quantity of import of each item during that period?

THE MINISTER OF COMMERCE AND INDUSTRY (SHRI KAMAL NATH): (a) While imports have increased, exports have also increased. The rise in imports is mainly due to the imports of petroleum and petroleum products.

(b) and (c) The five major items in imports which have shown a rise in the last five years, and their average annual increase in value, are:

Petroleum, Oil and Lubricant (30.65%), Electronic Goods (28.19%), Pearls, Precious and Semi-precious Stones (15.58%), Machinery (13.37%) and Gold and Silver (8.54%).

The organization was started in 1972 in Tilonia village in the Ajmer district. It is commonly called "The Barefoot College", the institution has worked to address basic needs, such as drinking water, health, education, and employment while involving individuals in the processes that govern their lives. Basic literacy, health and first aid skills are also taught. People with minimum paper qualifications are trained at the Barefoot College, as night school teachers, health workers, computer operators, in solar engineering, pump mechanics etc. The founder and director of the college is Shri Sanjit Roy.
