THE MINISTER OF STATE IN THE MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT (SHRIMATI SUBBULAKSHMI JAGADESAN): (a) and (b) According to the survey conducted by the National Sample Survey Organization (NSSO) during 58th round (July-December, 2002) estimated number of persons with disabilities in the country was 1.85 crore. Estimated number of blind and mentally retarded oersons are given below:
