Setting up of Commission for Minority Educational Institutions

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) and (b) According to the Common Minimum Programme of the UPA Government, a Commission for Minority Educational Institutions that would provide direct affiliation for minority professional institutions to Central Universities will be established. The matter is under consideration.

Achievement of Sarva Shiksha Abhiyan

(a) whether it is a fact that more than 25 per cent of the 400 million children of the country could not attend schools due to poor financial condition;

(b) if so, Government's response thereto and whether Government's Sarva Shiksha Abhiyan' plan is sorting out this problem; and

(c) if so, the details of the progress made through this plan particularly in Maharashtra?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) According to the estimates for year 2002-03, about 18% of the children in the age group 6 to 14 years and 63% of the children in the age group 14 to 18 years are not attending schools due to various reasons including financial and social conditions.

(b) and (c) Sarva Shiksha Abhiyan (SSA), which was launched in 2001-02, covers the entire country and addresses the needs of all children in the age group 6-14 years. The main objectives of the scheme are (i) To bring all 6-14 years age group children in schools/EGS Centres/Bridge courses by 2003 (ii) To ensure that all children in this age group to complete primary education of good quality by 2007 and elementary education by 2010. The progress made so far under SSA in the country and in Maharashtra is given in the Statement enclosed.
