THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRI JAI PRAKASH NARAYAN YADAV): (a) Bureau of Indian Standards (BIS) under Ministry of Consumer Affairs, Food & Public Distribution has issued licenses to use BIS standard mark to 1122 manufacturing units out of which 1115 units are for Packaged drinking water and 7 units are for Natural Mineral water upto 31st March, 2004. The BIS charges marking fee from licenses to whom licenses are granted for using BIS Standard Mark to recover operational expenses.

(b) to (d) National Water Policy-2002 envisages that Private Sector Participation should be encouraged in planning, development and management of water resources projects for diverse uses, wherever feasible which may help in introducing innovatic ideas, generating financial resources and introducing corporate management and improving service efficiency and accountability to users.
