Millionaires in the Country

†1357. SHRI JANESHWAR MISHRA: Will the Minister of FINANCE be pleased to state:

- (a) the number of persons who are millionaires in the country or the persons whose business is running in millions of rupees;
 - (b) the state-wise details of these persons; and
- (c) the number of persons out of them engaged in business and the details of business in which they are engaged?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI S.S. PALANIMANICKAM): (a) On the basis of returned income/loss, the number of individual assesses declaring income/loss of Rs. 10 lacs or above as on September 30th, 2003 were 70,217. Apart from this, the Income Tax Department does not maintain any data regarding the number of millionaires in the country.

- (b) This information, in the manner in which it is maintained in the Income-Tax Department, is given in Statement (See below).
- (c) Such details are not separately maintained. Compilation of such information would require collection of data from field units located all over the country, involving substantial time and effort, which may not be commensurate to the purpose sought to be achieved.
