THE MINISTER OF STATE IN THE MINISTRY OF DRINKING WATER AND SANITATION (SHRI RAMESH CHANDAPPA JIGAJINAGI): (a) to (c) Yes Sir. The names of the foreign funding agencies supporting the drinking water projects under implementation in various States and Union Territories are given in the Statement (See below). The details of impact in the form of Population/households covered by these projects are given in Statement (See below).

Under Swachh Bharat Mission (Gramin), a World Bank Project to support the Swachh Bharat Mission (Gramin) has been approved by Union Cabinet on 23.3.2016 with project cost of ₹ 9000 crore. The Project basically provides for incentivising States on the basis of their performance in the Swachh Bharat Mission (Gramin). The performance of the States will be gauged through an independent survey based measurement of certain performance indicators, called the Disbursement-Linked Indicators (DLIs). As the World Bank supported incentivisation project has become effective only recently, no funds have been released yet to any State.

(d) and (e) There is one ongoing project from State of Kerala as mentioned at S.No. 1 of Statement This Ministry has no other project proposal from State of Kerala in hand.
