Provision of potable water

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether it is a fact that there is a provision for providing potable water to 83 per cent households in the country;
 - (b) if so, the details, thereof;
- (c) the total number of households in each State of the country till end of 2003 for which there was a provision for providing potable water;
- (d) whether it is also a fact that the problem of potable water is getting severe due to deterioration in the quality of potable water;
 - (e) if so, the name of the such State and adversely affected, and
 - (f) the steps Government are taking in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI A. NARENDRA): (a) and (b) Although water supply is a State subejet, Government of India supplements the efforts of the States by releasing funds under Accelerated Rural Water Supply Programme. It is the endeavour of the Central Government to cover all rural habitations in the country with the facility of drinking water supply by rendering financial assistance and technical support to the State Governments.

- (c) Availability of water supply in rural areas is taken care of at the habitation level. As per reports received from the State Governments the status of coverage of rural habitations State-wise is annexed Statement-I (See below).
- (d) and (e) Deterioration in the quality of drinking water is one of the factors that affect the availability of potable water adversely. The Statewise position of the status of quality affected habitations is annexed Statement-II (See below)

(f) As per the guidelines of ARWSP, State Governments are required to utilize 15% funds released under ARWSP for submission projects on quality. Powers have been delegated to the States to plan, sanction and implement submission projects on quality.
