

administering the National Calamity Contingency Fund (NCCF) and the Calamity Relief Fund (CRF) through the Ministry of Agriculture and Ministry of Home Affairs respectively. With effect from the year 2002-03, the Department of Drinking Water Supply is also keeping 5% of the funds allocated under the Accelerated Rural Water Supply Programme (ARWSP) in a financial year to meet contingencies arising out of natural calamities and emergent situations, including drought. During the last three years, funds have been provided to the Government of Karnataka under various programmes as under:—

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI A. NARENDRA): (a) to (c) Water Supply is a State subject; Government of India supports the efforts of the States by releasing funds under Accelerated Rural Water Supply Programme for implementing rural water supply schemes. The criterion for inter-state allocation of funds under (ARWSP) is as under:—

The details of funds released during the last three years are at Statement (see below). Individual rural water supply schemes are planned and implemented by the State Governments themselves from ARWSP funds, and there is no need for taking up such proposal with the Government of India.
