

**Plight of weavers**

1613. SHRI MOTILAL VORA: Will the Minister of TEXTILES be pleased to state:

(a) whether Government are aware of the plight of the weavers in the absence of adequate protective legislation for them; and

(b) if so, whether his Ministry has any proposal to introduce any comprehensive scheme to give them adequate protection and to save them from exploitation by employers and middlemen?

THE MINISTER OF TEXTILES (SHRI SHANKERSINH VAGHELA): (a) The Handlooms (Reservation of Articles for Production) Act, 1985 provides for reservation of 11 items for production on handlooms only with a view to protect the interests of the handloom weavers in the country from the encroachment of the powerloom and mill sector on their livelihood. The Government has not received any report from any State Government of the plight of handloom weavers for want of adequate protective legislation.

THE MINISTER OF TEXTILES (SHRI SHANKERSINH VAGHELA): (a) and (b) Government of India has been implementing a number of schemes for implementation during Tenth Five Year Plan Period to promote the production of handloom textiles in the country which includes:

1. Deen Dayal Hathkargha Prothsahan Yojana
2. Handloom Export Scheme
3. Marketing Promotion Programme
4. Design Development and Training Programme
5. Integrated Handloom Training Programme
6. Mill Gate Price Scheme
7. Workshed cum Housing Scheme
8. Weavers Welfare Scheme
9. Bunker Bima Yojana
10. Implementation of Handloom (Reservation of Articles for Production) Act'1985
11. Reimbursement of CENVAT on Hank Yarn
12. Special Rebate on Handloom products.

(c) The target for production of handloom textiles by the end of Tenth Five Year Plan is 8700.00 million sq. mtrs.

(d) The estimated production during the first year of Tenth Plan was 5980 million sq. mtrs against the target of 7725 million sq. mtrs.
