In order to create a suitable policy environment and facilitate an efficient credit deliver system for infrastructre development, IDBI, IDFC, ICICI Bank, SBI, LIC, Bank of Baroda and Punjab National Bank have formed an Inter-Institutional Group (IIG). They will pool their resources on a callable basis, and a sum of Rs. 40,000 crore will be made available as and when necessary at a competitive interest rate. The IIG will ensure speedy conclusion of loan agreements and Implementation of infrastructure projects. Initially, airports, seaports and tourism will be the target sectors of the IIG.

#### Vacancies in PSUs

THE MINISTER OF STATE OF THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI SONTOSH MOHAN DEV): (a) 36 posts of Chief Executives and 96 posts of Functional Directors were vacant in Central PSUs as on 31.5.2004. These include 5 posts of Chief Executives and 25 posts of Functional Directors, which are kept in abeyance by the concerned administrative Ministries/ Departments.

- (b) The details of posts vacant as on 31.5.2004 and those falling vacant from 1.6.2004 to 31.3.2005 numbering 51, as per available information, are given in the enclosed Statement I and II respectively (See below).
- (c) Filling up of Board level vacancies in PSUs is a continuous process. There is an established procedure for this purpose. The selection is made by the Public Enterprises Selection Board (PESB) and the appointments are made by the concerned administrative Ministries/Departments after completing all the requisite formalities and obtaining approval of the

competent authority. A time schedule has been prescribed for completing various stages of recruitment and the process is initated by the PESB 12 months before the actual occurrence of the vacancies. As regards the exicuting vacancies, selection has already been made in 12 cases of Chief Executives and 28 cases of Functional Directors. In the remaining cases as well as in cases of vacancies arising during the current year, the selection process is already underway, except where the posts are kept in abeyance by way of conscious decision.
