conducted. However, the enquiry could not make much headway due to the following:

- (i) The section concerned reported that file movement registers were only available from 1993 onwards and no movement records were available for the period 1987-88.
- (ii) Though the file movement records of Commerce Secretary's office indicated the relevant dates on which the file had been submitted to the then Commerce Secretary, backward tracing of the file was not possible as the movement registers for the relevant period were not available with the office of concerned Joint Secretary and in the concerned Division.
- (iii) As per retention Schedule, the file registers are required to be maintained for 15 years while file movement registers are required to be maintained for one year. The manual of Office Procedure is silent about any other method to help in tracing the movement of a file after a lapse of 10 years or so.
- (iv) Personal staff, posted with the then concerned Joint Secretary, had retired from Government Service in the year 1991 and 1993.

Subsequently, therefore, the case was closed. However, detailed guidelines were issued to prevent loss of files. The missing file has since been re-constructed.
