Statement

Details of funds allotted and released to Nagaland under Sarva Shiksha Abhiyan during 2003-04 and 2004-05

Government of India releases Central assistance under Sarva Shiksha Abhiyan to State SSA Society which, in turn, releases funds to the districts. In 2003-04, the approved annual plan outlay for Sarva Shiksha Abhiyan for Nagaland was Rs. 2951.50 lakhs. However, the State did not release its share in 2002-03, and had an unspent balance of Rs. 863.52 lakhs as on 31st March, 2003. It was, therefore, decided that central assistance for 2003-04 would be released only after State share has been released. Intimation regarding release of state share was received only in March, 2004, whereafter Government of India, released Rs. 971.96 lakhs on 18.5.2004.

DD News Channel

657.SHRI DATTA MEGHE: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a)whether Government had started a news channel 'DD News' in November 2003 by scrapping an entertainment channel on Doordarshan;
 - (b)if so, the details thereof and the reasons therefor;
 - (c) the amount spent so far on this news channel;
- (d)whether viewership of the news channel has also declined, if so, the details thereof;
- (e)whether Government propose to review this decision and convert the DD News channel into the entertainment channel as before; and
 - (f) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI S. JAIPAL REDDY): (a) and (b) Doordarshan started a 24 hours 'DD News' Channel w.e.f. 3rd November, 2003 by converting their Metro Channel to provide free-to-air round the clock news, in both the terrestrial and satellite modes. It is the only terrestrial news channel in the country. Prasar Bharati has informed that the decision has been taken to fulfil a growing demand for news among the viewers, particularly among those without cable connection.
