- (a) whether any letter or Office Memorandum was received by the Deptt. of Communications regarding withdrawal of facilities provided to earlier All India SC/ST Telecom Employees Welfare Association; and
- (b) if so, what action has been taken by the MTNL Management thereon?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SHAKEEL AHMAD): (a) Yes, Sir.

(b) The department had written a letter to CMD, MTNL and BSNL on 28.5.2004, requesting them to formulate their own rules and plans for extending certain facilities to SC/ST Welfare Associations in consultation with National Commission for SC/ST. The matter is in process in MTNL.

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SHAKEEL AHMAD): (a) to (c) Comparative table showing total telephone connections working with Government owned PSUs and Private Operators as on 31st March for the last four years and their growth rate during last three years is given below:

  - (i) Government PSUs BSNL and MTNL have targeted to provide 105 lakh telephone connections during current year 2004-05, out of which 90% are Cellular and Wireless Local Loop (WLL) connections which are cost effective and preferred by customers.
  - (ii) Cabinet has approved reimbursement of Licence Fee and Spectrum Charges to BSNL on year to year basis during Tenth Five Year Plan for meeting losses incurred by BSNL in Rural Telephony.
