- (a) whether Government would introduce Personal Accident Insurance for customers who use Land-Line/WLL/Mobiles Services to attract more customers:

  - (c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SHAKEEL AHMAD): (a) There is no such proposal at present.

## **Outsourcing of IT services**

- (a) whether despite outsourcing of IT services having become hot political issue in election-bound US, Microsoft is planning to expand its operations in India;

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SHAKEEL AHMAD): (a) Many US companies including Microsoft in the IT sector are known to be expanding their business activities in India.

- (b) and (c) It is reported that Colt Telecom has already established its India operations. It will not be appropriate to establish a direct correlation between the expansion of a company's operations in India and the manpower rationalisation undertaken in its establishment in other countries.
- (d) NASSCOM has taken a number of initiatives to promote India as an ideal destination for global telecom and IT majors. These include organisation of events, conferences and fora (both domestic and international), global trade development programme and visa facilitation.
