## Call girls from Central Asian countries coming to India on tourist visas

\*346. DR. NARAYAN SINGH MANAKLAO: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether it is a fact that call girls from Central Asian countries are coming to India with tourist visa;

- (b) if so, the volume of such traffic;
- (c) what deterrent steps are being taken by the visa granting authorities in these countries to check the antecedents of the potential call girls;
- (d) whether there is any functional coordination mechanism and information sharing arrangement between Ministry of External Affairs and Ministry of Home Affairs to control the menace; and

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI E. AHAMMED): (a) and (b) Indian Missions abroad exercise due caution while issuing visas for various categories of visitors. Out of total arrival of foreigners in India i.e. 2.8 million in 2003, the number of persons coming from Central Asian countries constitute only 0.18%.

(c) to (e) The Ministries and Departments concerned in Government of India have regular consultations on issues relating to grant of visas.
