(b) and (c) Such complaints are received from time to time. As and when such complaints are received against registered recruiting agents, the concerned recruiting agent is directed to settle the matter. If the agent falls to settle the complaint, action is taken to suspend and thereafter cancel the registration certificate. In case of unregistered agents, the matter is referred to the concerned Police Authorities for taking action against them for violation of the provisions of the Emigration Act, 1983.

## **Employment Commission**

- (b) The Project aims at complete elimination of child labour in hazardous industries in the project area in a focused and integrated manner. The project specifically mentions target groups in the age group of 5-8 years, 9-13 years, and over 14 years. Parents are also proposed to be organized into self-help groups.
- (c) The states to be covered under the project are U.P., M.P., T.N., Maharashtra and NCT Delhi. The Sectors to be covered under the project are.
  - \* Hand-rolled bidi, cigarettes
  - \* Brass ware-including brassvases, planters, plates, dinner services, tea sets and other decorative objects
  - \* Hand made bricks
  - \* Fireworks
  - \* Footwear (leather, rubber, plastic)
  - Hand make locks
  - \* Hand dipped matches
  - \* Hand broken quarried stores
  - \* Hand blown glass bangles
  - Hand-spun, hand loomed silk thread, yarn and fabric
