- (b) The cost overrun for 274 projects is Rs. 13,380.64 crore.
- (c) Action Plan of the Government to control time overrun include the following among others.
 - (i) adoption of two-stage clearance system and stricter appraisal of project reports before investment approval;
 - (ii) taking up of projects for implementation only after funds have been fully tied up;
 - (iii) in-depth review of projects by the Government or monthly/ quarterly basis;
 - (iv) setting up of Empowered Committees in the administrative Ministries for review of departmentally executed projects;
 - (v) setting up of Standing Committees in the Ministries/ Departments to fix responsibility for time and cost overruns;
 - (vi) appointment of a nodal officer for each project with continuity of tenure; and
 - (vii) issue of guidelines on standard bidding documents for adoption.

Delay in completion of projects

1777. SHRI MOOLCHAND MEENA: DR T. SUBBARAMI REDDY:

Will the Minister of STATISTICS AND PROGRAMME IMPLEMENTATION be pleased to state:

- (a) whether implementation of Central sector projects remains sluggish despite Government's commitment to contain expenditure;
- (b) if so, whether delay in completion of projects has resulted in cost escalation of 8 per cent to Rs. 218606 crore, according to latest estimate of the Centre:

- (c) whether Government have abandoned 33 projects after incurring an expenditure of Rs. 1207.17 crores;
- (d) if so, what are the sectors on which these projects have been abandoned; and
- (e) the steps taken for timely implementation of the remaining projects.?

THE MINISTER OF STATE OF THE MINISTRY OF STATISTICS AND PROGRAMME IMPLEMENTATION (SHRI OSCAR FERNANDES): (a) No, Sir.

- (b) As on 1.4.2004, delay in projects costing Rs. 20 crore and above have resulted in the cost escalation of 6.4 per cent over the latest approved cost, of Rs. 2,32,231 crore.
- (c) There are 33 projects which are unfinished as they have been frozen/dropped after incurring an expenditure of Rs. 1207.17 crore.
- (d) The said 33 projects belong to sectors *viz* Coal, Fertilizers, Mines, Petroleum & Natural Gas, Power, Railways, Road Transport and Highways and Urban Development
- (e) Following steps have been taken for timely implementation of the remaining projects:
 - adoption of two-stage clearance system and stricter appraisal of project reports before investment approval;
 - (ii) taking up of projects for implementation only after funds have been fully tied up;
 - (iii) in-depth review of projects by the Government on monthly/ quarterly basis;

- (iv) setting up of Empowered Committees in the administrative Ministries for review of departmentally executed projects;

- (c) if so, the efforts being made to further curtail the cost overruns in the projects;
