concerned authorities have issued show cause notices to such recruiting agents. Government have tightened the emigration control for Iraq and neighbouring countries. With effect from 15 April, 2004, emigration clearance for Iraq has been suspended. With effect from May 7, 2004, emigration clearance has been suspended for Jordan, Kuwait and UAE in respect of ex-servicemen in order to prevent recruiting agents from using these countries for taking exservicemen to Iraq. Indian Missions in Iraq and its neighbouring countries have been instructed to extend all possible assistance and guidance to such persons intending to return to India
