- (c) if not, the reasons therefor; and
- (d) the effective measures being taken or proposed to be taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICA-TIONS AND INFORMATION TECHNOLOGY (DR. SHAKEEL AHMAD): (a) to (d) Expansion of postal network is a continuous activity subject to fulfillment of prescribed norms laid down by the Department and availability of resources.

During the first two years of the Tenth Plan the Department has opened 5 Branch Post Offices and 19 Panchayat Sanchar Sewa Kendras in Nagaland. The Department also proposes to support 25 Departmental Sub Post Offices and 36 Extra Departmental Branch Post Offices, sponsored by the State Government, running on Non-returnable Contributions basis, so that existing level of postal facilities are also sustained.
