THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI TASUMUDDIN): (a) and (b) In the 23rd meeting of the Central Consumer Protection Council (CCPC) held on 16th July, 2003 at New Delhi, it had been decided to set up Working Groups to study consumer related issues in details and to make suggestions/recommendations to better protect the interest of consumers. The following are the six Working Groups that have been set up:

- (i) Working Group on Food Safety.
- (ii) Working Group on Drugs, Pharmaceuticals, Medical Devices & Equipments.
