Sugar development fund benefits

1069. SHRI EKANATH K. THAKUR: Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether Government maintains a Sugar Development Fund to aid and assist sugar factories by way of grant of loans from the Fund;
 - (b) if so, the details of the Fund and its modus operandi;
- (c) the number & details of loan applications from sugar factories approved and sponsored by the Maharashtra Government and other State Governments for grant of loans;
 - (d) the number & extent of loans granted against such applications;
- (e) the details of sugar factory loans from Maharashtra pending with Government; and
- (f) whether the Sugar Development Fund benefits are extended to the sugar cane growers also; if so, the details thereof?

THE MINISTER OF STATE AND IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (DR. AKHILESH PRASAD SINGH): (a) Yes, Sir.

- (b) Amounts equivalent to the proceeds of the duty of excise levied and collected under the Sugar Cess Act, 1982, reduced by the cost of collection as determined by the Central Government together with any moneys received by the Central Government for the purposes of the Sugar Development Fund Act, 1982 is credited to the Sugar Development Fund after due appropriation made by Parliament by Law. The Fund is applied by the Central Government for purposes specified in Section 4 of the Sugar Development Fund Act, 1982, as amended vide the Sugar Development Fund (Amendment) Act, 2002. The manner of application for loans, their consideration and disposal are prescribed in the rules framed by the Government and notified in the Official Gazette namely the Sugar Development Fund Rules 1983.
- (c) and (d) Only the application for loans from the SDF for sugarcane development are required to be recommended and fowarded by the

Government of the State in which the applicant sugar undertaking is located. The details of applications recommended by the Government of Maharashtra and other State Governments and the loans approved in the period 1.4.2001 to 31.3.2004 are given in the Statement I (See below).

- (e) The required information is given in the Statement-II (See below).
- (f) In accordance with the Sugar Development Fund Rules 1983, the Central Government sanctions loans from the Sugar Development Fund for sugarcane development to sugar undertakings and not to the sugarcane growers directly. These loans are sanctioned in connection with the development of sugarcane for purposes covering inter-alia schemes for (i) rearing of seed nurseries; (ii) setting up of heat treatment plant; (iii) incentives to cultivators to switch over to improved varieties of sugarcane; (iv) irrigation schemes etc. These schemes are implemented by the sugar undertakings by involving the sugarcane growers in their area.
