- (b) whether Government propose to set up a separate regulatory body for regulating promotion and development of management education exclusively on the lines of AICTE;
 - (c) if so, the details thereof; and
 - (d) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) to (d) At present, there is no proposal to divest the All India Council for Technical Education (AICTE) of the responsibility to regulate management education and entrust it to a separate body. However, the Estimates Committee (2003-04) in its Nineteenth Report has *inter-alia*, expressed the view that AICTE should be divested of the responsibility relating to grant of approval and recognition to management courses and the same may be entrusted to a separate body. The Government has decided to consult the major stakeholders in the light of this recommendation.

Centrally sponsored scheme for teachers-education

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI. ASHRAF FATMI): (a) A Centrally-sponsored Scheme of Restructuring and Reorganisation of Teacher Education was launched in 1987 with five components.

- (b) and (c) The details are as under: -
 - (i) 41.17 lakh teachers were oriented in all States and Union Territories (except Andaman and Nicobar Islands) under the component of Mass/Special Orientation of School Teachers.

- (ii) Establishment of DIETs has been approved for 498 Districts in 28 States and 4 Union Territories.
- (iii) Upgradation of 124 Secondary Teacher Education Institutions has been sanctioned in 24 States and 1 Union Territory.
- (iv) Strengthening of SCERTs was sanctioned for 19 States and 1 Union Territory.
- (v) The fifth component viz. Establishment and Strengthening of University Departments of Education, through University Grants Commission, could not be implemented as such, though strengthening of a few selected University Departments of Education was sanctioned under the third component mentioned above.
