THE MINISTER OF DEVELOPMENT OF NORTH EASTERN REGION (SHRI P.R. KYNDIAH): (a) to (d) The information is being collected.

Maintenance of roads

1977. SHRI T.R. ZELIANG: Will the Minister of DEVELOPMENT OF NORTH EASTERN REGION be pleased to state:

- (a) whether Government are aware that most of the N.E.C. roads are abandoned after completion;
- (b) whether these roads will be maintained by the State Government or N.E.C; and

THE MINISTER OF DEVELOPMENT OF NORTH EASTERN REGION (SHRI P.R. KYNDIAH): (a) to (c) NEC funded roads after completion are handed over to the State Government for maintenance and State Governments are expected to maintain them. However, NEC has been trying to assist the State Governments for maintenance of some of the NEC funded roads by providing minimum funds since 2001-02. The funds provided are only for restoration of traffic on such roads. No major repair work is envisaged.

- (d) if so, the extent of decrease in labour force during the last five years and the financial savings as a result thereof?

THE MINISTER OF STATE OF THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI SONTOSH MOHAN DEV): (a) to (d) There is no formal classification of Industries as "Heavy". However, in so far as the Central Public Sector Enterprises, (PSEs) under the Department of Heavy Industry are concerned, one of the PSEs in the heavy electrical sector has made consistent profit during last five years due to many factors such as cost of inputs, market demand, level of competition including use of new and modern technology etc. The name of the PSE, manpower, profit made, and employment cost in 1999-2000 and 2003-2004 (Provisional) are given as under:

Though the company has had decrease in labour force over the last years (as reflected above), the employment cost has increased on account of increases due to pay revision, dearness and other allowances. This cost would nave been much higher without the decrease in manpower.
