been raised with the Government of Bangladesh a number of times at all levels. The Bangladesh Government continues to reaffirm its commitment not to allow activities in Bangladesh prejudicial to the interests of India and deny the existence of these groups in the Country.

Escape from Police Custody

2265. SHRI RAJKUMAR DHOOT: Will the Minister of HOMEAFFAIRS be pleased to state.

- (a) whether it is a fact that a double murder suspect, Jeetender Nayyar has escaped from the custody of Delhi Police;
 - (b) if so, the details thereof,
- (c) the number of under-trials who escaped from the custody of police during the last one year; and
- (d) the details of action taken against police personnel for deretiction of duty and steps taken to catch the culprits?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI S. REGUPATHY): (a) and (b) Yes, Sir. Shri Jeetender alias Kally, and under trial prisoner, who was taken to the All India Institute of Medical Sciences on 15th July, 2004 for medical check up, escaped from the police custody by duping the escorting Delhi Police personnel who became unconscious after taking cold drink offered by him.

(c) and (d) 48 under trial prisoners escaped from police custody in 2003 and up to 31st July, 2004 out of whom 27 have been apprehended so far. The action taken during the period 2003 and up to 31st July, 2004 against the Police personnel in connection with the escape of under-trial prisoners is indicated below:

Infiltration in Jammu and Kashmir

(a) and (b) As per the assessment made by various agencies and security forces, there has been an increase in the infiltration of terrorists from across the Line of Control/International Border in J&K since April 2004 compared to January-March 2004 apparently with the opening of the passes.
