- (b) the actual number of inmates in Tihar Jail as on 31st March, 2004 as against the normal capacity as on that date; and
  - (c) the action taken/proposed to be taken to normalize the situation?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI S. REGUPATHY): (a) Yes, Sir.

- (b) The actual number of prisoners lodged in Tihar Jail as on 31.3.2004 was 12,898 as against the sanctioned capacity of 4000 prisoners.
- (c) The action taken to solve the problem of overcrowding in Tihar Jail include: construction of three new Jails, organizing Special Courts in jail complex itself to dispose of cases relating to petty and minor offences; and taking up the matter with the District and Sessions Judge and the High Court of Delhi for early release of such prisoners who even after grant of bail, are not released for non-furnishing of surety bonds.

## NCW Inquiry into police atrocities in Agra

- (a) whether it is a fact that the National Commission for Women had conducted a statutory inquiry into the matter of alleged police atrocities on women in Kazipare (Agra);
  - (b) if so, what are findings/recommendations of the Inquiry Committee; and

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI MANIKRAO GAVIT): (a) Yes, Sir.

- (b) The Commission, *inter alia*, found that certain officials of the district level had handled the situation negligently. The Commission recommended disciplinary action against district level officials, payment of compensation to victims of this incident, relief to family of those who lost their family members, etc.
- (c) The recommendations have been sent to the State Government for appropriate action. The State Government has paid relief/financial assistance of Rs. 4,72,500/- to twenty affected families.
